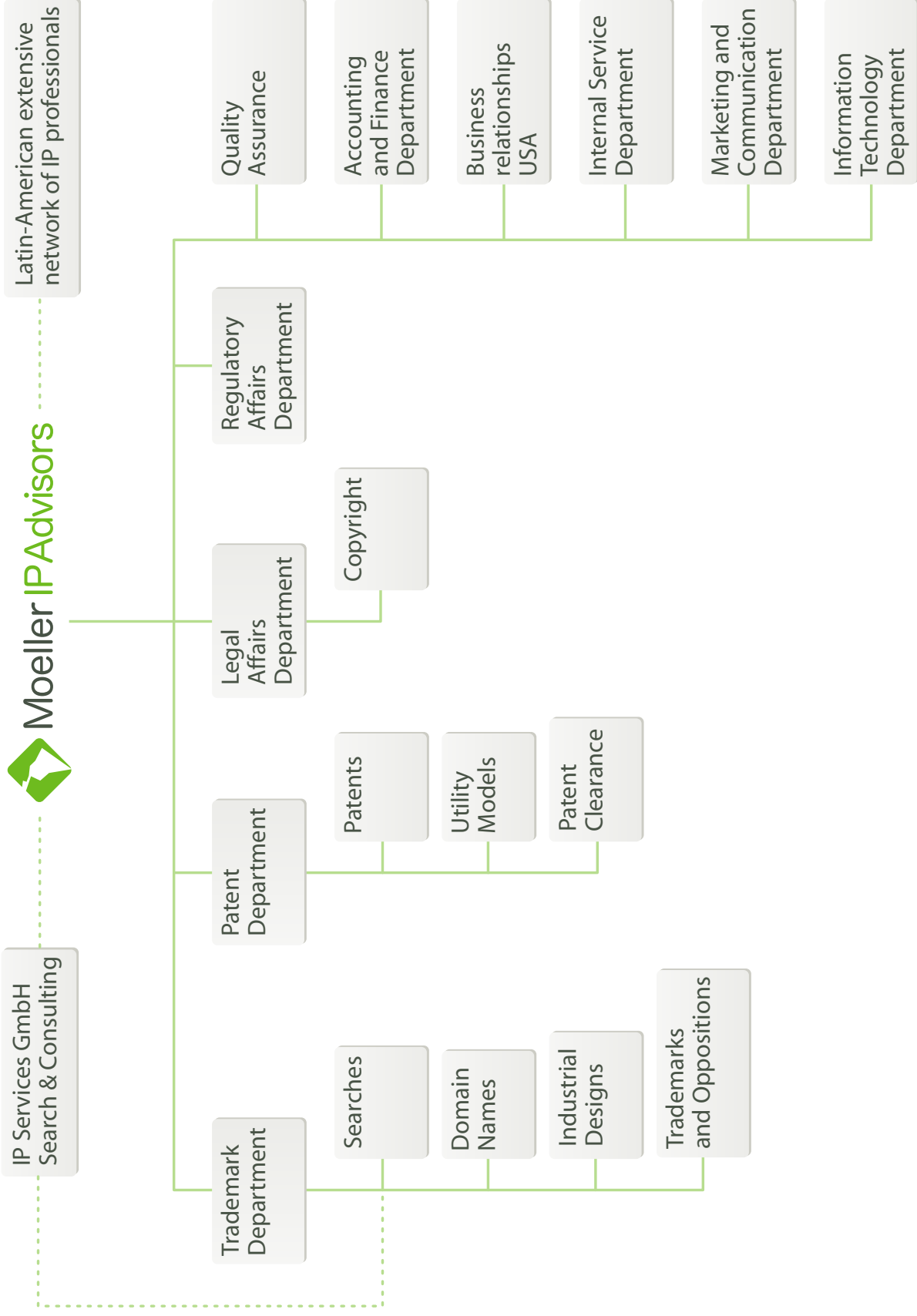
We are a law firm, with 80 years of experience, specialised and dedicated to providing a complete range of IP services throughout Latin America.
